#### **CALL FOR PAPERS**

Marking significant anniversaries is an occasion to recall successes and victories, but also to note losses and defeats and to pay tribute to the victims. For these reasons, in 2024, when 80 years have passed since the First Session of ASNOM, the Institute of National History and the Macedonian Academy of Sciences and Arts are organizing the International Scientific Conference "Anti-Fascism between Memory and Oblivion (on the Occasion of the 80<sup>th</sup> Anniversary of the First Session of Anti-fascist Assembly for the National Liberation of Macedonia)".

The focus of the international Scientific Conference will be on topics related to the First Session of ASNOM, but also on the victory achieved in the National Liberation and Anti-Fascist War. Naturally, other events from 1944 will also be covered, such as the enemy's winter offensive in Meglen, the February military campaign, the Spring Offensive, the final operations for the liberation of Macedonia, the establishment of the authorities of the people's power and important state-building institutions. In addition, it is expected that the conference will address events significant for the history of global anti-fascism in general and the perspectives on the contemporary treatment of fascism and anti-fascism from various aspects will be presented.

Today, eight decades after the holding of the First Session of ASNOM, it is difficult to express all the values of this key historical event given the multifaceted, lasting, and universal nature of the decisions made at the Session. Therefore, the Organizing Committee of the International Scientific Conference invites scholars from various scientific disciplines to contribute to the marking of the jubilee of this significant historical event.

Participants are responsible for their own travel and accommodation expenses.

Positively peer reviewed papers will be published in a Proceedings of the Conference.
